- Session Cancellation:** Individual session cancellations are to be made at least 24 hours in advance of the scheduled appointment. Athletes canceling on the day of their appointment will be charged for that session. Individuals failing to show for a scheduled appointment will forfeit that session.
- Tardiness:** All training sessions will begin promptly at the scheduled appointment time. Any lateness for a scheduled appointment will result in a modified training session. If an athlete is more than 15 minutes late for an appointment, they may participate, but it will be credited as a full session. If an athlete is repeatedly late for a training session, they will be given a written warning to arrive on time. Subsequent tardiness can result in removal from the program and forfeit of all monies paid or due.
